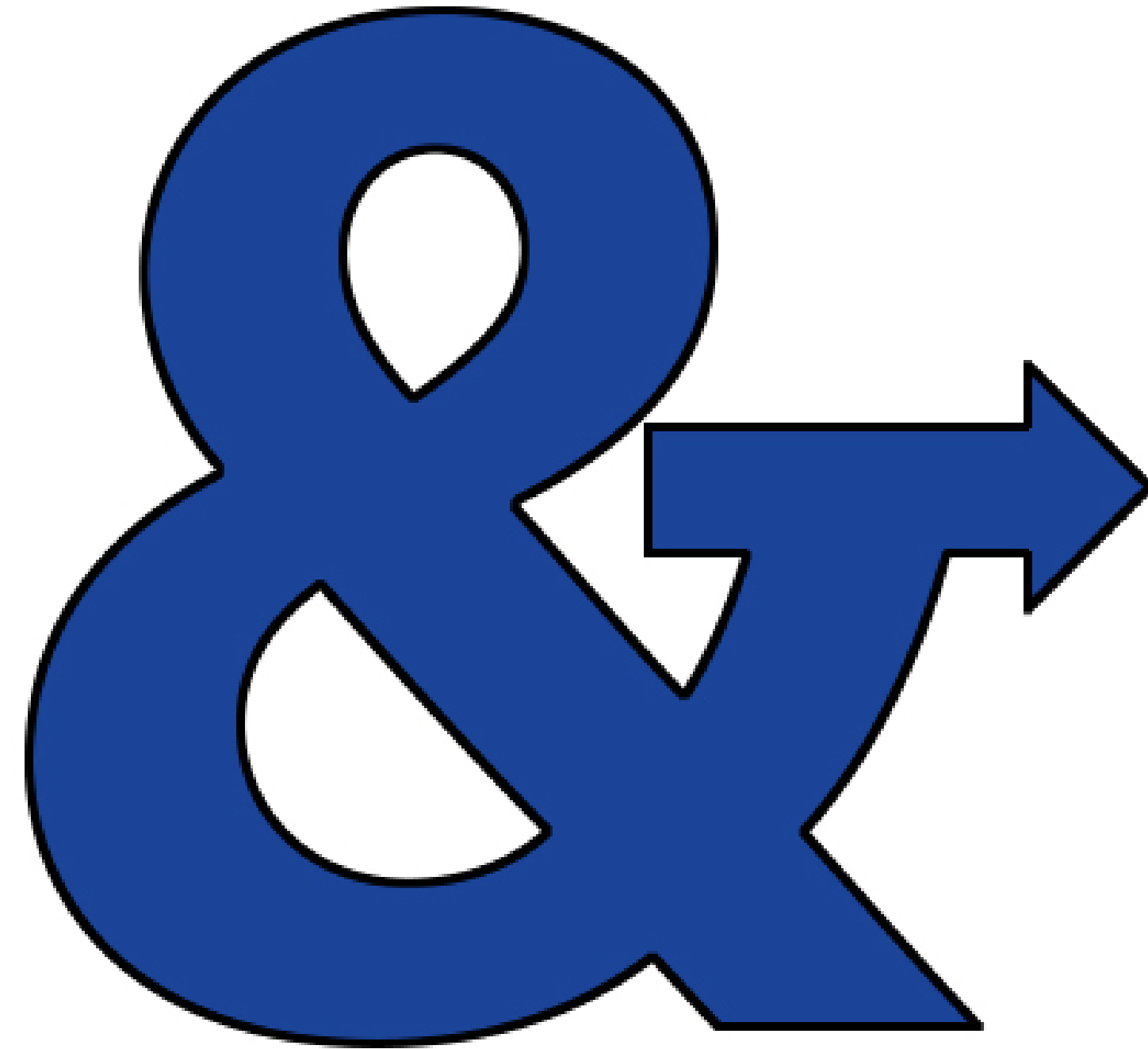

Doctoral Student Survey Award

- **Eligibility:** Current doctoral students who are members of DPOP.
- **Nominations:** Students will self-nominate by submitting a five-page proposal that describes their research question, the relevant existing research and theory, and their study design. The proposals must also contain an appendix listing the question wording and procedures to be used. (Although the proposals must be authored only by doctoral students, students may collaborate with faculty on any resulting research articles).
- **Evaluation Criteria:** Developed in 2023, this award is designed to fund survey research for a doctoral student. The winning proposal will earn \$1,500 to collect survey data over the next year, with the findings to be presented at the ASC Annual Meeting the following year. Winners selected by Awards Committee and representative from UC.

2023 WINNER OF THE
Young Scholar Award



Dr. Colleen Berryessa
Rutgers School of Criminal Justice

Colleen Berryessa is an Assistant Professor at the Rutgers University School of Criminal Justice. Her research, utilizing both qualitative and quantitative methods, considers how psychological processes, perceptions, attitudes, and social contexts affect the criminal justice system, particularly related to courts, sentencing, and forms of punishment broadly defined. She primarily examines these issues, using interdisciplinary methodologies, in relation to three areas: 1) how psychological and social phenomena influence public perceptions, support, and subsequent consideration of practices, policies, and the philosophical foundations surrounding sentencing; 2) how psychological and social phenomena influence the discretion and decision-making of criminal justice actors during the sentencing process; and 3) how psychological and social phenomena bear on lay motivations for and effects of expanded forms of legal and social punitiveness beyond the formal punishment stages of the criminal justice system. Dr. Berryessa received her Ph.D. in Criminology from the University of Pennsylvania. Before Penn, she graduated from Harvard University with a B.A. in Government and Mind, Brain, and Behavior and she served as a CIRGE research fellow at Stanford University.

Dr. Brandon K. Applegate
University of South Carolina

Brandon Applegate is currently a professor in the Department of Criminology and Criminal Justice at the University of South Carolina, where he currently serves as Director of Graduate Programs and previously chaired the department (2011-2022). He received his Ph.D. in Criminal Justice from the University of Cincinnati in 1997, and taught for 14 years at the University of Central Florida before joining USC. He teaches undergraduate, master's, and Ph.D. courses on corrections, juvenile justice, and methodological issues. He has published more than seventy-five articles and chapters on public views of correctional and juvenile justice policies, jail issues, decision-making among criminal justice professionals, and correctional treatment. He also co-edited (with Francis T. Cullen) *Offender Rehabilitation: Effective Correctional Intervention*. His research has been supported by grants and contracts from the National Institute of Justice, Ohio Department of Youth Services, Florida Department of Children and Families, the Orange County (FL) Commission, and the Center for Drug-Free Living. Brandon Applegate served the Academy of Criminal Justice Sciences as President (2015-2016) and Secretary (2002-2004) and the Southern Criminal Justice Association as President (2006-2007) and Director - at-Large (1999-2002). He has served on the editorial boards of *Justice Quarterly*, *Journal of Criminal Justice Education*, *the American Journal of Criminal Justice*, and *Corrections: Policy, Practice, and Research*.

Chair

1. Term of office for the Chair shall be two years, beginning one year after their election.

4. All Executive Counselors will assist the Division Chair with executive decisions for the Division.

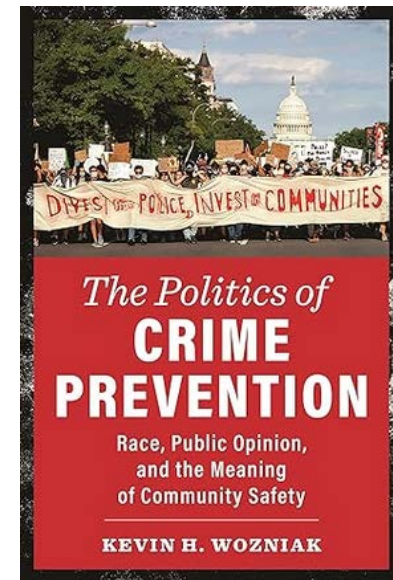
