2024 Award Winners



Dr. Luzi Shi is an assistant professor of criminology and criminal justice at the University of Rhode Island since Fall, 2023. She graduated with a doctoral degree in criminal justice from SUNY -Albany in 2020. She has also worked as an assistant professor of criminal justice at Bridgwater State University between 2020 and 2023. She conducts survey research to understand the social sources of biases, punitiveness, and stigma in the context of criminal justice and their influence on crime control policies. She also conducts experiments to test ways to reduce stereotypes and misperceptions of marginalized social groups. With her research work, she was awarded the University at Albany Dissertation Research Fellowship Award, the BSU Class of 1950 Distinguished Faculty Research Award, and New England Board of Higher Education North Star Collective Faculty Fellowship. Her recent proposal to study hate crimes against Asian women in the U.S. was granted a research award by the American Psychology Association Division American Psychology - Law Society. Her publications have appeared in Criminology, Criminal Justice and Behavior, Journal of Experimental Criminology, among others.



Dr. Francis T. Cullen is a Distinguished Research Professor Emeritus and Senior Research Associate at the University of Cincinnati. He has published more than 500 works and has earned more than 78,000 citations. He is a Past President of the American Society of Criminology and of the Academy of Criminal Justice Sciences. Among his awards, he was honored in 2013 by his alma mater, Bridgewater State University, with a *Doctorate in Public* Service and in 2022 was the Winner of the Stockholm Prize in Criminology. His research interests have focused on correctional policy and on criminological theory. For much of his career, he has conducted public opinion surveys showing the American public's abiding embrace of rehabilitation, ambivalent support for punitive policies, and willingness to hold white - collar offenders accountable. More recently, he has focused attention on the impact of racial attitudes —especially White nationalism and racial sympathy—on criminal justice policy preferences.

Public Opinion Policy

Vice Chair

- 1. Term of office for the Vice- Chair shall be two years.
- 2. The Vice Chair shall preside over Division meetings in the absence of the Chair and shall be empowered to conduct all necessary business of the Division if the office of Chair is vacant or if the Chair is unable to serve.
